## Section 6. Accidental Release Measures

### Personal Precautions, Protective Equipment and Emergency Procedures:

**For non-emergency personnel:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Put on appropriate personal protective equipment.

**For emergency responders:** If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For nonemergency personnel".

### Methods and Materials for Containment and Clean Up:

### Precautions for Safe Handling

## Section 8. Exposure Controls/Personal Protection

### Appropriate engineering Control

Good general ventilation should be sufficient to control worker exposure to airborne contaminants

**Environmental exposure controls:** Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. 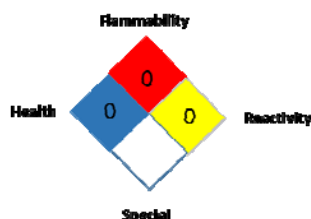
